INSTRUCTIONS

FOR COMPLETING AND SENDING AN APPLICATION FORM TO EXERCISE RIGHTS

1. Who has the right to fill in and send a APPLICATION FORM TO EXERCISE RIGHTS.

EU REGULATION 2016/679 and the Personal Data Protection Act (PDPA) deal only with the protection of personal data of individuals. In this connection, APPLICATION FORMS TO EXERCISE RIGHTS may be submitted only by natural persons.

2. APPLICATION FORM TO EXERCISE RIGHTS.

The APPLICATION FORM TO EXERCISE RIGHTS is recommended.

The rights can be exercised by the data subject by submitting a written application in free text, which shall contain sufficient information to allow the administrator to fulfill it. The use of the application form will allow the request to be processed faster and without further involvement of the data subject.

Your name and contact details are needed so that the applicant can be uniquely identified and notified in a timely manner if additional information is needed. If the contact information for the applicant is not filled in and additional information from the data subject is required, the application form will be considered after the applicant has contacted the administrator again.

The data contained in the application form is personal data and it is necessary for the administrator to fulfill the application form. Once executed, the application form will be retained along with other personal data that the administrator will continue to store and process lawfully.

3. Necessary clarifications by the applicant.

In describing the application form, it is recommended that the applicant shall specify:

- what information is requested;
- why personal data should/can be corrected or deleted – in this regard the administrator may request additional documents or information;
- format for providing personal data in case of exercised right of transfer and person – recipient of the data
- please, specify what actions in processing your personal data you object.

4. Ways to send the completed application form:

The application form may be sent to the SPEEDY Data Protection Officer:

- on paper in a SPEEDY office at address: SOFIA, GDPR, Office 2 SOFIA – SOMAT, 22 ABAGAR Str., SOFIA CITY LOGISTICS PARK, upon request, after presentation of an identity document to the courier's office to identify the sender.
- electronically, at the address: gdpr@speedy.bg and the application form must be signed with a Qualified Electronic Signature (QES) or other certification chain that allows identification of the sender.

5. Deletion of data

SPEEDY AD shall process personal data in compliance with the General Regulation for Personal Data Protection and the provisions of the legislation in the Republic of Bulgaria, which provide for certain restrictions on the exercise of rights by data subjects. Even if the request contains the information necessary for its consideration, there may be a legal impediment to its fulfillment.
